

Articulation Agreement Between Baker College and All State Approved Secondary CTE Programs



The purpose of this agreement is to facilitate the transition of students from high school occupational and/or Career and Technical Education (CTE) program to **Baker College**. This program is offered at all **State-Approved Career and Technical Programs in Michigan**.

General Conditions and Requirements:

1. Student must apply for Articulated Credit at Baker College within one year (12 months) of high school graduation.
2. Student must complete the Application for Articulation, attach a high school transcript and send to runningstart@baker.edu.
3. Student must complete the course (inclusive of the identified segments) with a "B-" or higher to be eligible for articulation.
